GUIDANCE NOTES FOR PARENTS AND GUARDIANS

ELIGIBILITY FOR ENTITLEMENT

If you are in receipt of any of the following you will be entitled to Free School Meals for your child:

- Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)
- Income Support
- Income Based Job Seekers Allowance
- Income related Employment Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999 (from the National Asylum Support Service)
- The guarantee element of State Pension Credit
- Child Tax Credit (provided you're **not also entitled to Working Tax Credit**) and have an annual income of no more than £16,190

Note: If you are in receipt of Working Tax Credit during the four week period immediately after your employment ceases, or after you start to work less than 16 hours per week, your child/children are entitled to free school meals

CONFIRMATION OF ELIGIBILITY

Your application may be checked using The Department for Education Free School Meals Eligibility Checking Service using the information you have provided in Part A of this form. The results will be a yes/no confirmation and your child's school will be informed of this.

DOCUMENTARY EVIDENCE

You may be requested by the school to provide documentary proof of entitlement.

CHANGE OF CIRCUMSTANCE

You must inform the school immediately of any change in your benefit entitlement.

Once you have completed the form please return it to YOUR CHILD'S SCHOOL as soon as possible.

Free school meals cannot be provided until the school has received the form and verified your eligibility.
