

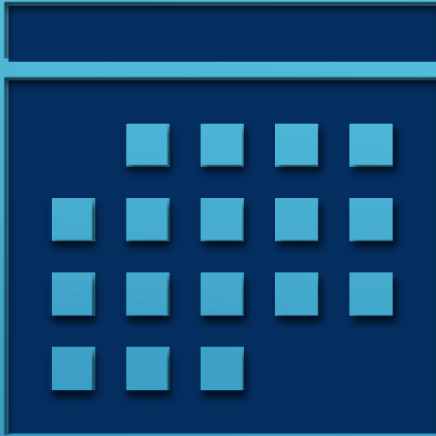
YEAR 13 – LEAVERS ASSEMBLY





- ▶ Due to the constantly changing guidelines, we can't yet confirm the format of Results Day
- ▶ We will confirm via email what the procedure will be – in other words, whether you come in to collect your results, or if we will email them out to you
- ▶ Don't worry – in the event of a remote results day, there will be an advice service so that you can access the Sixth Form team, Curriculum Leaders, Adviza and the Examinations Team

RESULTS DAY – THURSDAY 13TH
AUGUST



- ▶ Check UCAS Track. It should update at 8 am – certainly not midnight!
- ▶ Do not assume a successful Confirmation decision means you got your grades – UCAS cannot confirm grade results
- ▶ Make sure you have access to a phone, fully charged, full of credit
- ▶ Make sure your Track ID details are up to date

UCAS – CONFIRMING YOUR PLACE

WHAT NEXT?

- ▶ Conditions of offer met?
 - ▶ If you get the offer for your Firm (F) choice – you are going there
 - ▶ If you do not get into your Firm choice but meet the conditions of your Insurance (I) choice – you are going there
 - ▶ IN BOTH CASES YOU MUST TAKE UP THAT PLACE OR WITHDRAW FROM THIS YEAR'S CYCLE
- ▶ Conditions of offer not met
 - ▶ You may be given a changed course offer – you do not have to accept this – 5 days to reply
- ▶ Conditions of offer exceeded?
 - ▶ See Adjustment
- ▶ Unsuccessful?
 - ▶ See Clearing and Clearing Plus

UCAS - ADJUSTMENT

- ▶ For those students who do better than they were expecting and exceed their conditions
- ▶ It may be possible to 'trade up'
- ▶ You can shop around for an alternative without losing your firm place
- ▶ You usually have 5 days
- ▶ There are no lists – you have to do the research

UCAS - CLEARING

- ▶ Either for those who have not met conditions of either Firm (F) or Insurance (I) OR those who are applying late OR those who received no offers
- ▶ You need to research which universities have places – only from www.ucas.com
- ▶ If eligible for Clearing you will be given a Clearing number
- ▶ Clearing is entered on Track
- ▶ A new service for 2020 – Clearing Plus
